Royal Brisbane and Women's Hospital Foundation (ABN 37 882 212 480) (**RBWHF**) is committed to protecting the privacy of individuals and their personal information and complies with the *Privacy Act 1988* (Cth) (**Privacy Act**).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information you provide to RBWHF.

You understand that:

1. RBWHF is the party who is collecting your personal information and can be contacted at [privacy@rbwhfoundation.com.au](mailto:privacy@rbwhfoundation.com.au) or alternatively you can write to us at PO Box 94, Royal Brisbane Hospital, Queensland 4029.
2. RBWHF will collect your personal information directly from you. In certain circumstances, RBWHF may be required to collect personal information from third parties, depending on the nature of your enquiry.
3. The RBWHF is collecting your personal information because:
  - a) We engage and communicate with you to provide opportunities where philanthropic support and community engagement can further enable the advancement of life-saving research and patient care.
  - b) Outside of operational engagement we will provide updates, discounts, or other content or products and services that may be of interest to you and to provide you with direct marketing communications from us or our related entities and associates (using direct mail, telemarketing, email, SMS, and MMS messages);

and you acknowledge and agree to your personal information being collected and used for, and in connection with, these purposes and any other purpose described in our Privacy Policy.

4. If we do not collect this personal information in connection with the purposes in paragraph 3, then:
  - a) Outside of operational engagement to garner philanthropic and community support and steward all key stakeholders we will be unable to send you direct RBWH Foundation marketing communications (unless you have consented to such communications through your other dealings with RBWHF).
5. Your personal information may be disclosed to the following classes of people and organisations in connection with the purposes in paragraph 3:
  - a) Service providers who assist us in providing our services to you.
  - b) Royal Brisbane and Women's Hospital and other hospitals in the Queensland health system, so that those parties can offer updates or other content or products and services that may be of interest;
  - c) Granting or research bodies and potential donors who are interested in supporting improvements in patient care initiatives and research.and
  - d) any other organisation as expressly covered in our Privacy Policy.
6. It is possible that some of the information collected may be disclosed to RBWHF's related body corporate or service providers outside of Australia. You **consent** to your information being disclosed to a destination outside Australia for this purpose, including but not limited to **the United States, New Zealand, South Africa and Ireland** and you understand and acknowledge that Australian Privacy Principle 8.1 will not apply to such disclosures of your personal information.
7. RBWHF's Privacy Policy sets out the process as to how you can access and correct any of your personal information collected under this form as well as to how you can make a
