

## Privacy Collection Statement - RBWH Foundation Talent Consent Form

Royal Brisbane and Women's Hospital Foundation (ABN 37 882 212 480) (**RBWHF**) is committed to protecting the privacy of individuals and their personal information and complies with the *Privacy Act* 1988 (Cth) (**Privacy Act**).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information you provide to RBWHF.

## You understand that:

- RBWHF is the party who is collecting your personal information and can be contacted at <u>privacy@rbwhfoundation.com.au</u> or alternatively you can write to us at PO Box 94, Royal Brisbane Hospital, Queensland 4029.
- RBWHF will collect your personal information directly from you. In certain circumstances, RBWHF may be required to collect personal information from third parties, depending on the nature of your enquiry.
- 3. The purpose of RBWHF collecting your personal information is:
  - (1) to obtain your consent for our use of your name or likeness in (or in relation to) quotes, or audio-visual media (including photographs, images, audio or video recordings) for our publicity, advertising, social media, web or other commercial purposes;
  - (2) to offer you updates, discounts, or other content or products and services that may be of interest to you and to provide you with direct marketing communications from us or our related entities and associates (using direct mail, telemarketing, email, SMS and MMS messages);

and you acknowledge and agree to your personal information being collected and used for, and in connection with, these purposes and any other purpose described in our Privacy Policy.

- 4. If we do not collect this personal information in connection with the purposes in paragraph 3, then:
  - (1) we will be unable to publish your quotes/images/tapes/videos in publications including print media, electronic media and mailing (unless you have consented to such disclosures through your other dealings with RBWHF); and
  - (2) we will be unable to send you direct marketing communications (unless you have consented to such communications through your other dealings with RBWHF).
- 5. Your personal information may be disclosed to the following classes of people and organisations in connection with the purposes in paragraph 3:
  - (1) Any persons that access or receive RBWHF's publications or advertising;
  - (2) service providers who assist us in providing our services to you;
  - (3) Royal Brisbane and Women's Hospital and other hospitals in the Queensland health system so that those parties can offer updates or other content or products and services that may be of interest; and
  - (4) any other organisation as expressly covered in our Privacy Policy.
- 6. It is possible that some of the information collected may be disclosed to RBWHF's related body corporate or service providers outside of Australia. You consent to your information being disclosed to a destination outside Australia for this purpose, including but not limited to the United States, New Zealand, South Africa and Ireland and you understand and acknowledge that Australian Privacy Principle 8.1 will not apply to such disclosures of your personal information.
- 7. RBWHF's Privacy Policy sets out the process as to how you can access and correct any of your personal information collected under this form as well as to how you can make a complaint if RBWHF has breached the Privacy Act in the handling of your personal information.
