You understand that:

- 2. RBWHF will collect your personal information directly from you. In certain circumstances, RBWHF may be required to collect personal information from third parties, depending on the nature of your enquiry.
- 3. The purpose of RBWHF collecting your personal information is:
 - to obtain your consent for our use of your name or likeness in (or in relation to) quotes, or audiovisual media (including photographs, images, audio or video recordings) for our publicity, advertising, social media, web or other commercial purposes;

 - (ii) we will be unable to send you direct marketing communications (unless you have consented to such communications through your other dealings with RBWHF).

You **consent** to your information being disclosed to a destination outside Australia for this purpose, including but not limited to **the United States**, New Zealand, South Africa and Ireland and you understand and acknowledge that Australian Privacy Principle 8.1 will not apply to such disclosures of your personal information.
